

Eligibility Criteria for St. Dom's Hall of Fame Nomination

Section 11.01 Individual Award

(a) Athlete Criteria: (All Minimal Criteria needs to be met while at Saint Dominic Academy)

- a. Athletes will become eligible for nomination five years after graduation.
- b. Athletes must have graduated from Saint Dominic Academy.
- c. Eligibility Criteria to be considered, but not limited to:
 1. Participant was an active member of the team
 2. Participant was an active member and contributor, not the lead, but viable member of the team.
 3. Participant was a key player, team leader, and played an instrumental role to the success of the team and/or program.
 4. Honorable Mention All-State
 5. 2nd Team All-State
 6. 1st Team All-State
 7. Conference Player of the Year Award Winner
 8. Travis Roy Award (or the equivalent of) Semi-Finalist, Finalist, or Winner.
 9. LA Hall of Fame Presidents Award Winner
 10. Special awards or certificates received (merit of award or certification is to the discretion of the Athletic Hall of Fame Committee)
 11. School Record Holder
 12. Receipt of Division 1 Scholarship for Athletics
 13. Went on to Professional Career in Athletics

(b) Coach Criteria:

- a. Must have coached a varsity team for minimum of 5 years
- b. Coaches are eligible upon their retirement or after five years of leaving employment at Saint Dominic Academy
- c. Coached Conference or State Championship Team
- d. Coach of the Year Honors
- e. Strong consideration for members of a Recognized State Hall of Fame in the Sport he/she coached

(a) State Championship Team

Section 11.03 Lifetime Achievement Award

(a) Outstanding lifetime contribution to the Saint Dominic Academy Athletic program as an athlete, coach, or supporter. This category was created to honor those folks whose contributions far exceed even those inducted into the Athletic Hall of Fame.

Section 11.04 Special Nomination (Exceptions to the above criteria)

- (a) Under unique circumstances the Hall of Fame Committee has the ability to waive the number of years' requirement and/or graduation requirement with 2/3 - majority vote of the committee.
- (b) The following athletes, coaches, teams and sports contribution candidates shall be eligible for nomination's
 - a. Selected into any national hall of fame
 - b. Achieved a world record
 - c. Has participated in the Olympics, World Games, representing the United States.
 - d. Played for or won an amateur national championship or professional championship on a team or as an individual.

Section 11.05 General Nomination Process

- (a) Once nominated, nominees will be active for five (5) years. After five (5) years those not selected will be placed on an inactive list and eligible for re-nomination.
- (b) Living or deceased nominees will be accepted.
